## ABOUT THE CLINICS:

The clinics are open to dogs and handlers of all skill levels, but it is recommended that beginning dogs have some prior exposure to stock. The focus will be to help participants understand the basics of controlling livestock using a dog, whether for competition or practical purposes, and how to help a dog use his instincts to work in a partnership with the handler.

The methods used are based on shaping the dog's natural drive into controlling a group of livestock for the handler as the handler gradually takes control of the dog. The training process is designed to produce a thinking and relaxed helpmate.

**Becky Bailie** is recognized as a top competitor and trainer of working Australian Shepherds, with a number of ASCA National and Finals Championship titles to her credit. *Starstuff* is an ASCA Hall of Fame Kennel noted for producing quality working Australian Shepherds.

## REGISTRATION:

- \$180.00 for 3 days per dog/handler team.
- Auditors are welcome at \$75.00 for 3 days. Family members of participants are welcome to audit at no charge.
- Clinics are limited to 8 participants. A \$90 deposit is required to reserve your spot. Deposits are not refundable unless we can fill your reservation from the waiting list.

## GENERAL INFORMATION:

- Clinics begin at 8:30 AM and end around 6:00 PM, with 2 working sessions per day. Lunch is included for participants and auditors, and may be purchased by non-participant family members for \$7.50 per day.
- Videotaping is permitted ONLY of your own dog.
- Dogs must be leashed or crated when not working.
- Individuals are responsible for any damage done to stock, facilities, and/or equipment.
